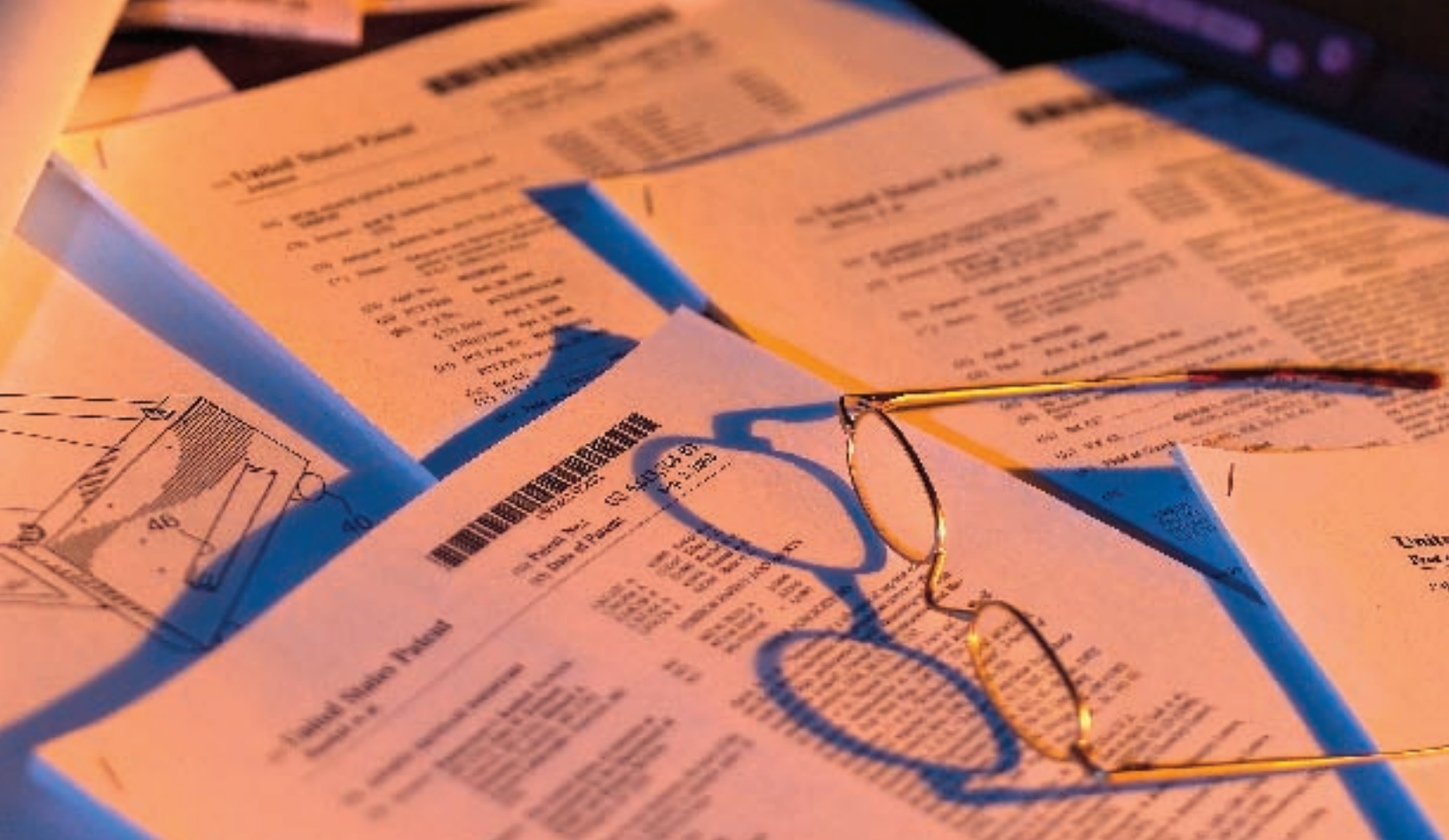

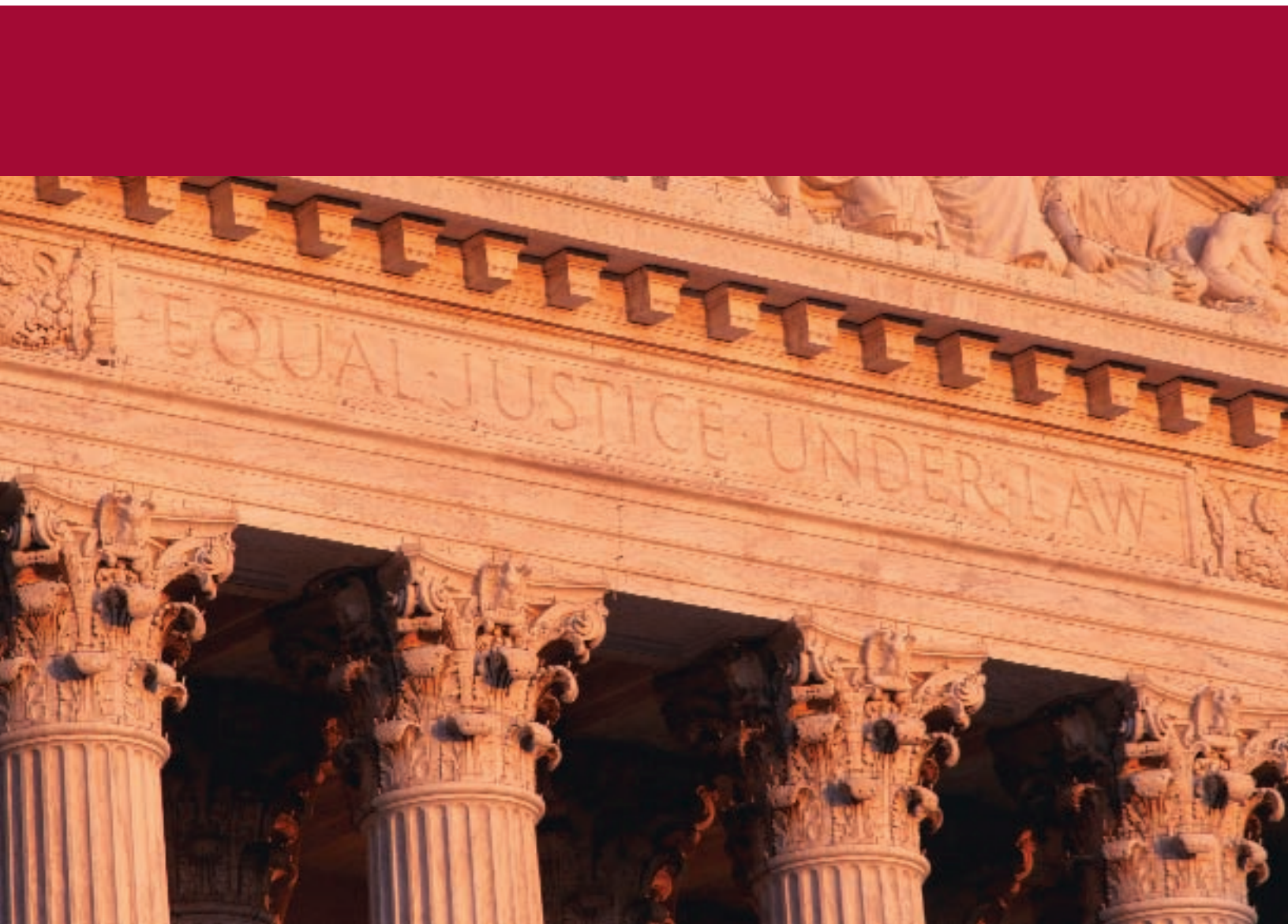

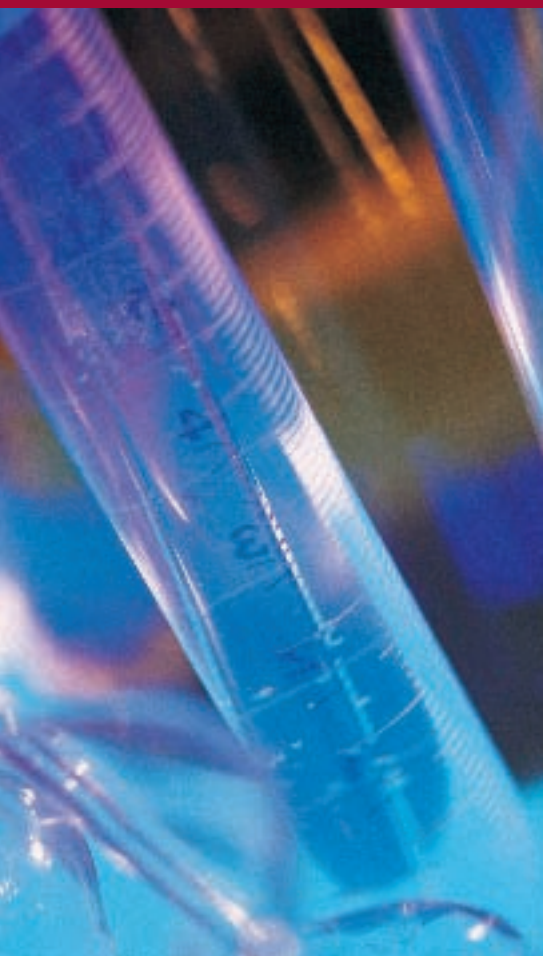

## Mechanical Design

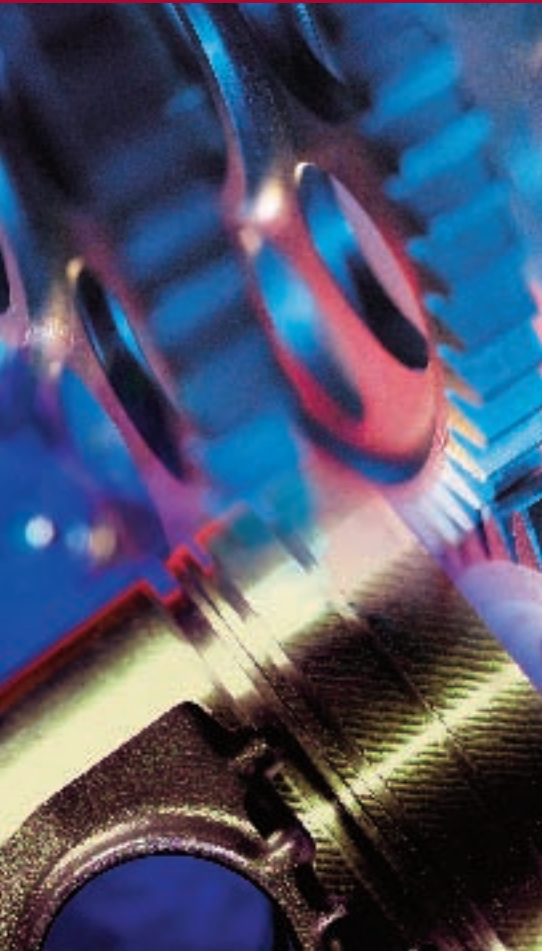
